



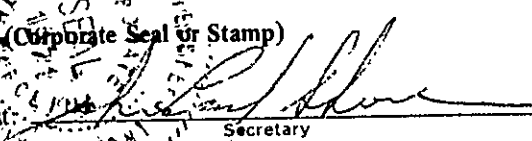

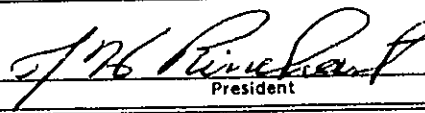
THIS CORPORATION DEED, made this 26th day of July, 1974, by J. & J. ASSOCIATED DEVELOPERS, INC., a Corporation of Winston-Salem, Forsyth County, North Carolina, party of the first part, to ROY S. FULTON and wife, EARSLEY N. FULTON

of Forsyth County, North Carolina, parties of the second part, WITNESSETH: that said party of the first part in consideration of Ten And No/100 Dollars (\$ 10.00 ovc) and other valuable considerations to it paid by parties of the second part, receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to said parties of the second part and their heirs and assigns, a certain tract or parcel of land in Clemmons Township, Forsyth County, North Carolina, bounded as follows: BEGINNING at an iron stake in the northern right of way line of a proposed 60 foot wide street, a southwest corner of Roy S. Fulton, said iron stake being distant South 24° 58' West 627.46 feet from the southwest corner of Lot 1 as shown on the Plat of Loire Valley, Section One, recorded in Plat Book 24, Page 182 of the Forsyth Registry, thence from said point of beginning and with the western line of Roy S. Fulton, North 24° 58' East 430 feet to an iron stake in said line, thence North 65° 02' West 145 feet to an iron stake in the eastern right of way line of a proposed cul de sac, having a radius of 50 feet; thence with the same as it curves South 51° 36' West a chord measurement of 44.7 feet to an iron stake in the eastern right of way of a proposed 60foot wide road, thence with said right of way line South 24° 58' West 408.5 feet to an iron stake, the northeast intersection of two 60-foot wide proposed roads, thence with the northern right of way line of a 60-foot wide road as it curves South 72° 10' East 36.97 feet to a point, thence continuing with said right of way line South 71° 12' East 129.2 feet to an iron stake the point and place of Beginning. Being a part of Tax Lot 20M, Block 4234. Said description is in accordance with a survey made by Joseph Parks Bennett, Jr., R.L.S., dated July 16, 1974.

TO HAVE AND TO HOLD the aforesaid tract, parcel or lot of land, all privileges and appurtenances thereto belonging to the said parties of the second part and their heirs and assigns, to their only use and behoof forever;

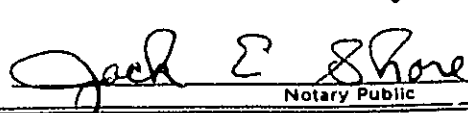
