

ARTICLES OF INCORPORATION

OF

M & G LAB, INC.

I, the undersigned, being a natural person of the age of twenty-one (21) years or more, do hereby associate into a business corporation under the laws of the State of North Carolina, as contained in the General Business Corporation Act of the State of North Carolina, and the several amendments thereto, and to that end do hereby set forth:

1. The name of the Corporation shall be M & G LAB, INC.
2. The period of duration of the Corporation shall be perpetual.
3. The purpose of the Corporation shall be to operate an orthodontic dental laboratory, providing dental laboratory services to licensed dentists.
4. The aggregate number of shares which the Corporation shall have the authority to issue is One Thousand (1,000) shares, of one class, to be known as common stock and to be without par value. The Corporation shall not commence business until at least One Hundred (100) shares are sold and at least Three Hundred Dollars (\$300) is paid to the Corporation for the issuance of such shares.
5. The address of the initial registered office of the Corporation is 1700 Hawthorne Road, Winston-Salem, North Carolina, County of Forsyth, and the name of the initial registered agent at such address is Dr. Thomas G. Handy.




