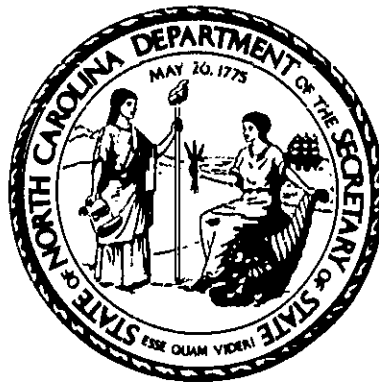

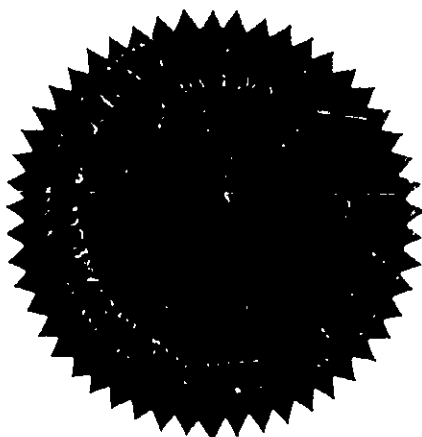



ARTICLES OF INCORPORATION

OF

G & G MECHANICAL, INC.

I, the undersigned being a natural person of the age of twenty-one years or more, hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

1. The name of the corporation is G & G MECHANICAL, INC.
2. The period of duration of the corporation is perpetual.
3. The purposes for which the corporation is organized are:
 - (a) To generally carry on the business of working with industrial equipment in any manner including the purchase and sale of same.
 - (b) To engage in any other lawful activity, including processing, selling, brokering, factoring, distributing, lending, borrowing or investing in any type of property whether real or personal, tangible or intangible; extracting and processing natural resources; transporting freight or passengers by land, sea or air; collecting and disseminating information or advertisement through any medium whatsoever; performing personal services of any nature; and entering into or serving in any type of management, investigative, advisory, promotional, protective, insurance, guarantyship, suretyship, fiduciary or representative capacity or relationship for any persons or corporations whatsoever.
4. The corporation shall have authority to issue ONE THOUSAND (1,000) shares of common stock, having a par value of TEN DOLLARS (\$10.00) per share.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is ONE HUNDRED DOLLARS (\$100.00) in cash or property of equivalent value.
6. The shareholders of the corporation shall have no pre-emptive right to acquire additional or treasury shares of the corporation.
7. The address of the initial registered office of the corporation in the State of North Carolina is Forsyth County, North Carolina; and the name of its initial registered agent at such address is Larry G. Reavis at Suite 325, NCNB Plaza, Winston-Salem, North Carolina 27101.
8. The number of directors constituting the initial board of directors shall be two (2) and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify, are:




