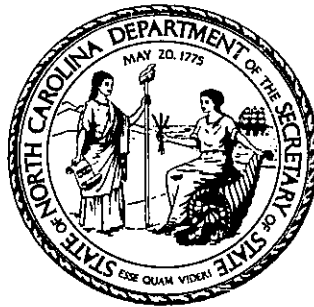

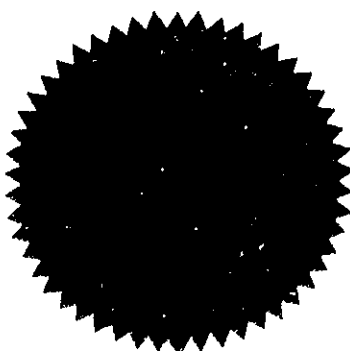

ARTICLES OF INCORPORATION

OF

S. AND J. COMMUTER BUS SERVICE, INC.

We, the undersigned natural persons of the age of eighteen years or more, for the purpose of forming a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled Business Corporation Act, and the several amendments thereto, hereby set forth articles of incorporation as follows:

I

The name of the corporation is S. and J. Commuter Bus Service, Inc.

II

The period of duration of the corporation shall be perpetual.

III

The purpose or purposes for which the corporation is organized are:

(a) to carry on the business of motor bus proprietors and carriers of passengers and goods in and around the State of North Carolina, and in such other places as may from time to time be thought fit;

(b) To operate as a commuter bus service, for the purpose of carrying passengers and goods in intrastate commerce.

(c) To let motor buses, engines, machinery, and other chattels and things used for any of the above purposes; to enter into contracts with any person or company as to interchange of traffic, running powers, or otherwise; and to obtain all powers and authorities necessary to carry out or extend any of the above objects.

(d) To carry on the business of leasing, and renting automobiles, trucks, buses, trailers and other motor vehicles.

IV

The aggregate number of shares which the Corporation shall have authority to issue is Ten Thousand Shares of common stock with a par value of Ten (\$10.00) Dollars per share.

V

The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is One Thousand (\$1000.00) Dollars.

VI

The address of the initial registered office of the Corporation is 4254 Northampton Drive, Winston-Salem, Forsyth County, North Carolina, 27105, and the name of the initial registered agent at such address is Rudolph Sullivan.

VII

The number of directors of the Corporation may be fixed by the bylaws, but shall not be less than three except as permitted by statute.

The number of directors constituting the initial board of directors shall be three, and the name and address of each person who is to serve as a director until the first meeting of the shareholders or until his successor is elected and qualifies are:

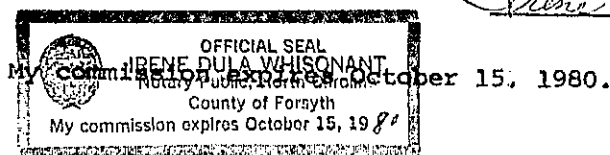
