

ARTICLES OF INCORPORATION

FOR

P AND L SNACK SALES, INC.

- I, the undersigned being of the age of Eighteen (18) years or more, do hereby form a business under the Laws of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporations Act" and the several amendments thereto, and to that end do hereby set forth:
- 1. That the name of the corporation shall be P and L Snack Sales, Inc.
 - 2. That the duration of the corporate existence shall be perpetual.
