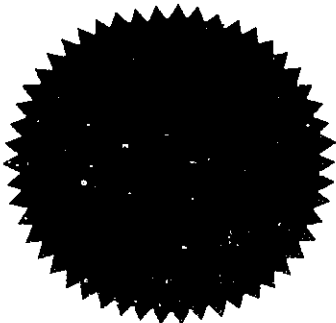

ARTICLES OF INCORPORATION

FOR

P AND L SNACK SALES, INC.

I, the undersigned being of the age of Eighteen (18) years or more, do hereby form a business under the Laws of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporations Act" and the several amendments thereto, and to that end do hereby set forth:

1. That the name of the corporation shall be P and L Snack Sales, Inc.
2. That the duration of the corporate existence shall be perpetual.
3. That the purpose for which this corporation is organized is:
 - (a) To purchase for resale in dispensers known as a "Box" snack foods and to distribute and supply said "Boxes", and
 - (b) To purchase and sell for the use and benefit of the corporation such real and personal property as will further and develop the business, and
 - (c) To enter into contracts and leases which will further the business, and
 - (d) To distribute and supply such other food items to be distributed by said "Box" or by such other mechanical device which is for the benefit of the business.
 - (e) To perform any and all functions not inconsistent with the laws of the State of North Carolina, Chapter 55 of the North Carolina General Statutes and the amendments thereto in furtherance of the goals for which this corporation is established.
4. That the authorized capital for the corporation shall be One Hundred Thousand Shares of One Dollar (\$1.00) par value stock.
5. That the minimum capital contribution to be received by the corporation before it shall commence operation shall be Five Hundred Dollars (\$500.00).



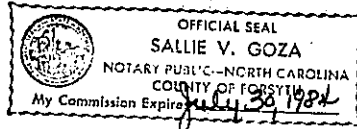
