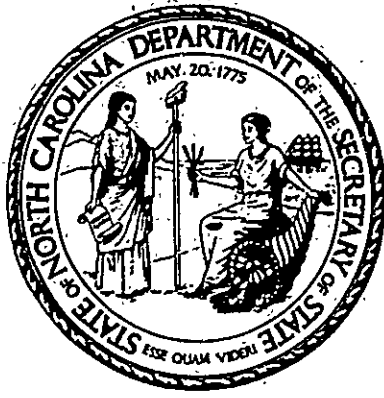

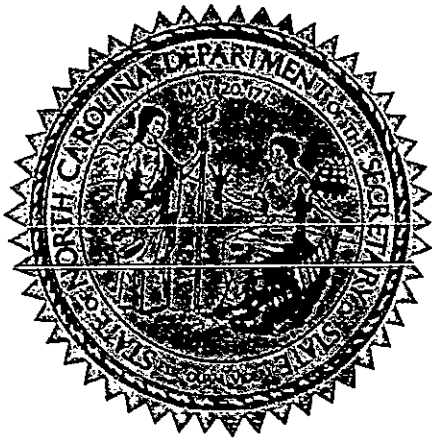

THIS CERTIFIES that the undersigned do hereby organize a corporation under and by virtue of the laws of the State of North Carolina, and to that end do hereby set forth:

I.

The name of the corporation is S & E ASSOCIATION, INC.

II.

The period of duration of the corporation shall be perpetual.

III.

The purposes for which the corporation is organized are:

- (a) To sell any and all types of industrial supplies and any other purpose or purposes which may be lawfully carried on in the State of North Carolina.
- (b) To do any or all of the things herein set forth to the same extent as a natural person or persons might or could do and in any part of the world, as principals, agents, contractors, trustees, or otherwise, and either alone or in company with others.
- (c) In general to carry on any other incidental business in connection therewith not forbidden by the laws of the State of North Carolina and with powers conferred upon corporations of this character by the laws of the State of North Carolina.

IV.

The corporation shall have the authority to issue ten thousand (10,000) shares of common stock, having a par value of \$10.00 per share.

V.

The sale of ten (10) shares at Ten Dollars (\$10.00) per share shall be the minimum amount of consideration for its shares to be received by the corporation before it shall commence business.

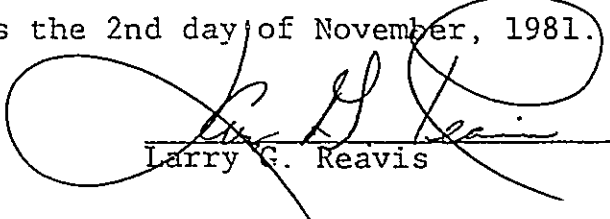

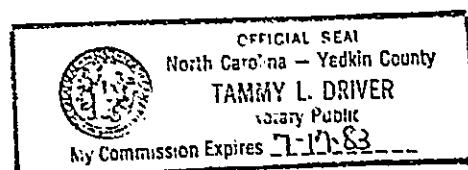

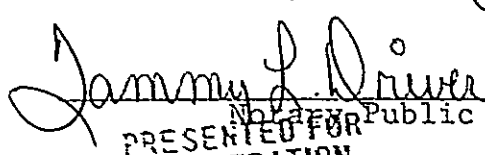
