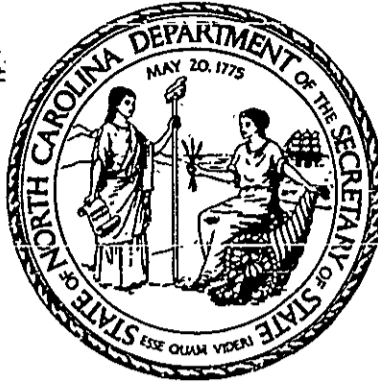

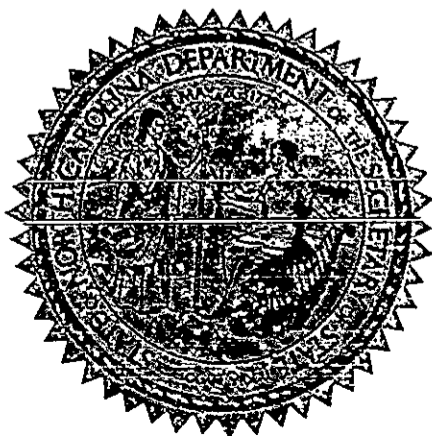

ARTICLES OF AMENDMENT TO THE CHARTER
OF
J & B TYPESET, INC.

The undersigned Corporation executes these Articles of Amendment for the purpose of amending the Charter of the Corporation:

1. The name of the Corporation is J & B Typeset, Inc.
2. The following amendment to the Charter of the Corporation was adopted by its shareholder on the 28th day of January, 1982, in the manner prescribed by law:

BE IT RESOLVED by the Shareholder and Directors of the Corporation that Article I of the Charter of the Corporation is hereby amended as follows: The name of the Corporation is Tri-Ad Press, Inc.

3. At the time of the adoption of the foregoing amendment, there were 1,500 shares of stock outstanding, all of which were entitled to vote on the foregoing amendment.

4. The number of shares voted for such amendment was 1,500; and the number of shares voted against such amendment was 0.

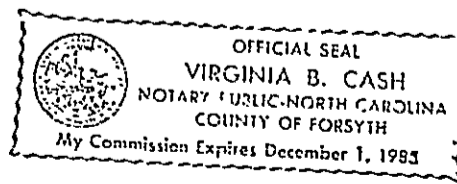
5. The amendment herein effected does not give rise to dissenter's rights to payment for the reason that the only effect of such amendment is to change the name of the Corporation.

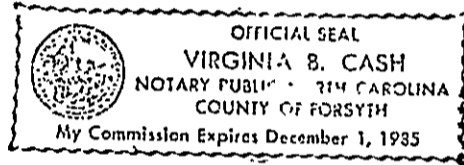
