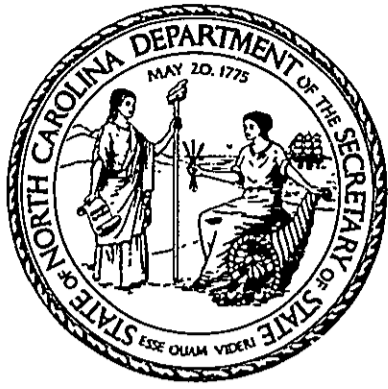

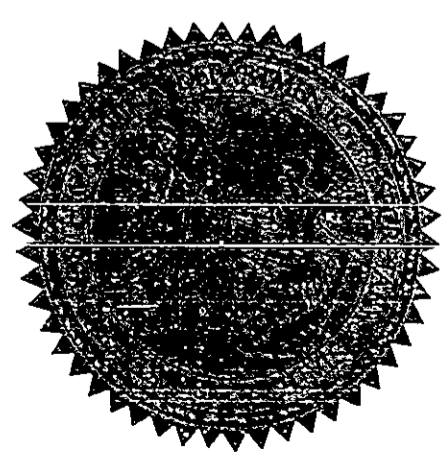

ARTICLES OF AMENDMENT  
TO THE CHARTER OF

E & I RULE ENTERPRISES, INC.  
(NAME OF CORPORATION)

The undersigned corporation, for the purpose of amending its Articles of Incorporation and pursuant to the provisions of Section 55-103 of the General Statutes of North Carolina, hereby executes the following Articles of Amendment

1. Name of the corporation E & I Rule Enterprises, INC.

2. At a regularly convened meeting of the shareholders of the corporation held on the 10th day of February, A. D. 19      , the following amendment to the charter of the corporation was adopted by vote of the shareholders:

THAT section number (9 $\frac{1}{2}$ ) of the Charter be amended to read as follows:

The aggregate number of shares which the corporation shall have authority to issue is (10,000) divided into one common class "A", at par value per share be (\$1.00).

3. The number of shares of the corporation outstanding at the time of the adoption of said amendment or amendments was 6600, and the number of shares entitled to vote thereon was 6600. The designation of each class entitled to vote as a class on the adoption of said amendment or amendments, and the number of shares of each such class was as follows:

4. The number of shares voted for amendment or amendments was 6600; and the number of shares voted against the amendment or amendments was none. Voting within each class entitled to vote as a class was as follows:
