Hartman, deceased, of Forsyth County, State of North Carolina, parties of the first part; and R and L PROPERTIES of Forsyth County, State of North Carolina, party of the second part;

That whereas John H. Hartman died, leaving a Last Will and Testament which is duly probated and recorded in the Office of the Clerk of the Superior Court of Forsyth County, therein naming said parties of the first part, as his Co-Executors; and whereas, said parties of the first part have duly qualified and are now acting as such Co-Executors; and whereas, said Will gave and granted unto said parties of the first part as such Co-Executors full power and authority to sell and convey real estate belonging to said estate; and whereas, said parties of the first part are of the opinion that this sale and conveyance is in the best interest of said estate.

NOW, THEREFORE, said parties of the first part, acting as Co-Executors as aforesaid, in consideration of the sum of Twenty-seven Thousand Five Hundred Fifty and No/100 Dollars (\$27,550.00), to them in hand paid, the receipt of which is hereby acknowledged, and under authority of the power given unto them in said Will, have bargained and sold and by these presents do bargain, sell and convey unto the said party of the second part and its successors and assigns, certain lands belonging to said estate and lying and being in the County of Forsyth and State of North Carolina, and more particularly described as follows:



Beginning at an old iron in the margin of the right-of-way of a state-maintained road, said iron stake being a corner with James Beedings, running thence South 88 deg. 3 min. East 747.5 feet to an iron stake; thence South 87 deg. 55 min. East 243.1 feet with the Beedings line and line of William Allgood to a stone, said stone being a corner with William Allgood; running thence South 3 deg. 35 min. West 836.77 feet with the Allgood line and the line of C.A. Hoots to an iron stake a corner with Hoots and Lonnie Ray Speaugh; running thence North 87 deg. 38 min. West 134.2 feet to an iron stake, a corner with Lonnie Ray Spaugh and Louise S. Stout; iron stake, a corner with Lounte Ray opended.

running thence North 2 deg. 22 min. East 295.7 feet to an iron
North 86 deg. 08 min. West 469.0 feet with axle; running thence North 86 deg. 08 min. West 469.0 feet with the lines of Louise S. Stout, H. West 100.10 reet to an iron stake; running thence North 15 deg. 22 West 100.10 feet to an iron stake; thence North 61 deg. 32 min. FTELLITE min. West 215.0 feet to an iron stake; thence North 15 deg. 22 min. West 154.07 feet to an iron stake; thence North 15 deg. 22 min. West 130.93 feet to an iron stake, the point and place of Beginning.
