

ARTICLES OF AMENDMENT TO THE CHARTER OF H PROPERTIES, INC.

The undersigned Corporation hereby executes these Articles of Amendment for Othe purpose of amending its Charter:

1. HORTH CAROLINE

1. The name of the Corporation is H Properties, Inc.

- 2. The following amendment to the Charter of the Corporation was adopted by its shareholders on the 1st day of June 1983, in the manner prescribed by law:
