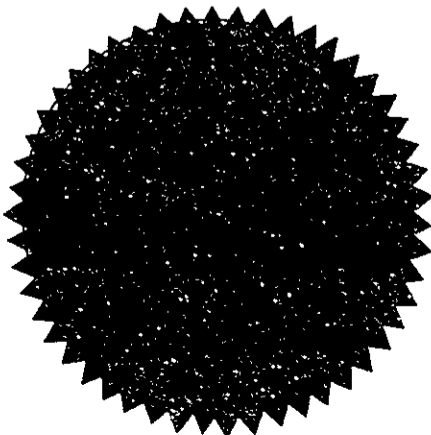

The undersigned, being the age of eighteen or more, do hereby form a business under the Laws of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled, "Business Corporation Act", and the several amendments thereto, and to that end do hereby set forth:

1. The name of the corporation shall be T & D MASONRY COMPANY, INC.
2. The duration of the corporation shall be perpetual.
3. The purposes for which this corporation is organized are:

(a) To engage in and conduct a general masonry construction, engineering, excavating, and contracting business.

(b) Directly, or through ownership of shares of any corporation, to purchase or otherwise acquire, hold, manufacture, develop, sell, exchange, mortgage, create a security interest in, pledge, hypothecate, deal in and dispose of land, commodities, building materials, and other personal and real property of every kind and interest therein;

(c) To construct, install, remove, repair, inspect, report upon, buy, sell, handle and deal in structures and attachments thereto of all kinds, to solicit, bid for, enter into and perform contracts for the performance of construction work and the furnishing of related accessories, materials and supplies of all kinds;

(d) To enter into, make, and perform contracts and services of every kind and description, with any person, firm, association, corporation, municipality, county, state, body politic or government or dependency thereof, and

(e) To engage in any lawful act or activity for which corporations may be organized under the Laws of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina and any amendments thereto, known as the "Business Corporation Act".

4. The corporation shall have authority to issue One Hundred Thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.

5. The minimum amount of consideration to be received for its shares and with which the corporation shall commence business is One Hundred Dollars (\$100.00).


