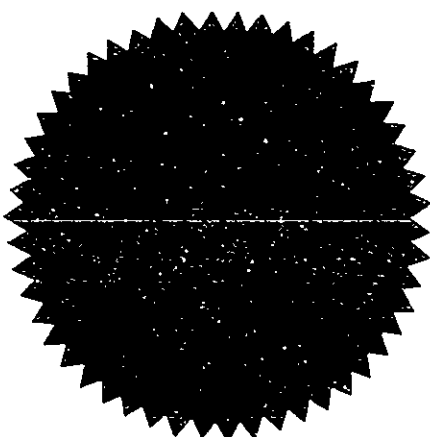

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

1. The name of the corporation is H & H Garage Door, Inc...
2. The period of duration of the corporation is perpetual.
3. The purposes for which the corporation is organized are:
  - (a) selling, installing, purchasing, servicing and repairing garage doors and garage door accessories; and
  - (b) to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The corporation will have authority to issue one hundred thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Dollar (\$1.00) in cash or property of equivalent value.
6. The address of the initial registered office of the corporation in the State of North Carolina is 3935 Yokley Street, Winston-Salem, North Carolina, 27107; and the name of its initial registered agent at such address is Roy D. Honaker. *Joseph County*
7. The number of directors constituting the initial board of directors shall be two (2); and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify, are:



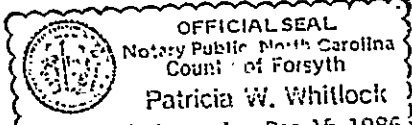
