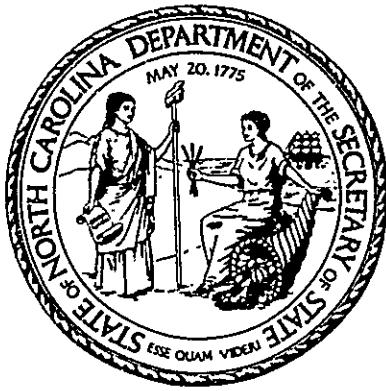

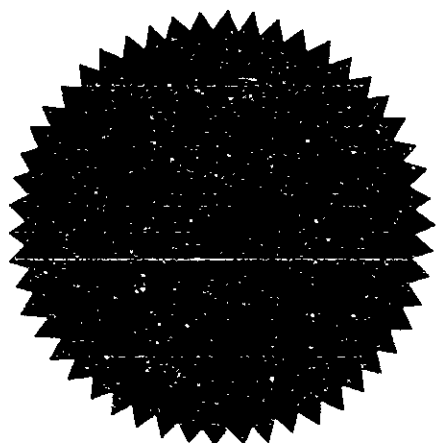

ARTICLES OF INCORPORATION

OF

I, the undersigned, being a person of full age, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and be virtue of the laws of the State of North Carolina.

I.

The name of the corporation shall be J & G Provence Trucking Co., Inc.

II.

The period of duration of the corporation shall be perpetual.

III.

The purposes for which the corporation is organized are:

(a) To buy, sell, hold, rent and lease equipment, such as but not limited to trucks, tractors, trailers, motor vehicles, and to enter into any and all transactions incident thereto;

(b) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

IV.

The corporation shall have authority to issue Ten Thousand Shares (10,000) of stock with a par value of Ten Dollars (\$10.00) per share of stock.

V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is Five Hundred Dollars (\$500.00) in cash or property of equivalent value.

VI.

The shareholders of the corporation shall have preemptive right to acquire additional or treasury shares of the corporation.

VII.

VIII.





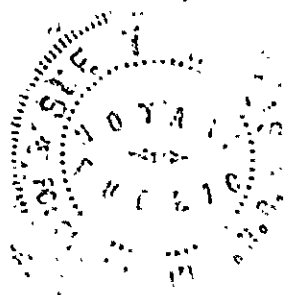
