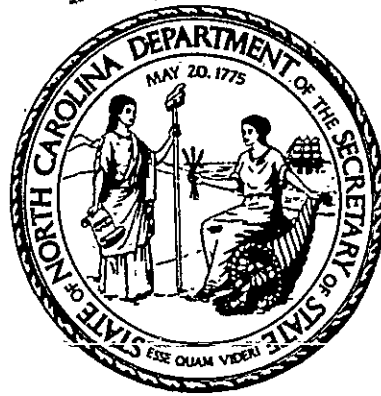

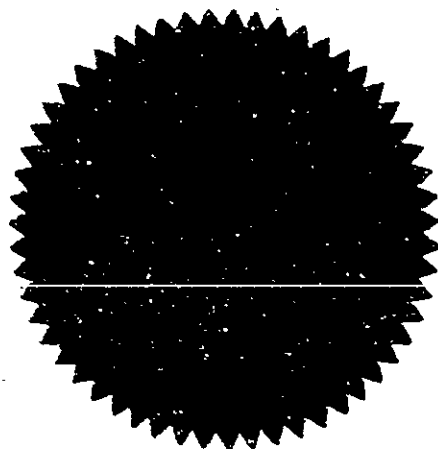

ARTICLES OF INCORPORATION

THE UNDERSIGNED, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

I.

- a) The name of the Corporation is Z. WALL & COMPANY, INC.
- b) The period of duration of the Corporation shall be perpetual.
- c) The purpose or purposes for which the Corporation is organized are:
 - 1) To carry on a business for the reporting of advertisements through a printed newspaper or periodical, together with all related transactions and business associated therewith.
 - 2) To engage in any lawful activity, including, but not limited to, constructing manufacturing, raising or otherwise producing, and repairing, servicing, storing, or otherwise caring for any type of structure, commodity, or livestock whatsoever; processing, selling, brokering, factoring, distributing, lending, borrowing or investing in any type of property whether real or personal, tangible or intangible; extracting and processing natural resources; transporting freight or passengers by land, sea, or air; collecting and disseminating information or advertisement through any medium whatsoever; performing personal services or any nature; and entering into or servicing in any type of management, investigative, advisory, promotional, protective, insurance, guarantyship, suretyship, fiduciary or representative capacity or relationship for any person or corporation whatsoever.
 3. To engage in an advertising business by writing, formulating, and advising as to advertisements for corporations, firms, and individuals with reference to advertising either their or its business; to write advertisements and to supervise printing and circulation thereof for a consideration.
- d) The aggregate number of shares which the corporation shall have authority to issue is 1,000 divided into one (1) class. The designation of each class, number of shares of each class, series, if any, within each class, and the par value, if any, of the shares of each class, or a statement that the shares of any class are without par value, is as follows:

The preferences, limitations and relative rights in respect to the shares of each class are as follows:

e)	The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is \$100.00.
f)	The address of the initial registered office of the Corporation is 2824 Old Greensboro Road, Forsyth County, North Carolina 27101, and the name of the initial registered agent at such address is DORTHULA BARON-BUTLER. Located in the city of Winston-Salem, NC.
g)	The number of directors of the Corporation may be fixed by the bylaws, but shall not be less than three (except as permitted by N.C.G.S. §55-25).

The number of directors constituting the initial board of directors shall be three, and the name and address of each person who is to serve as a director until the first meeting of shareholders or until his successor be elected and qualified is:
