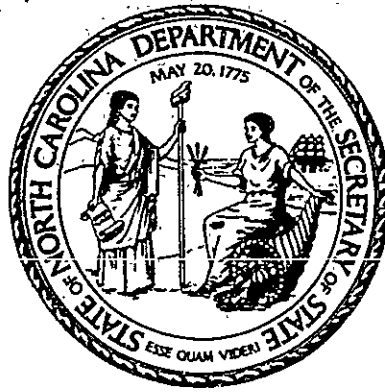

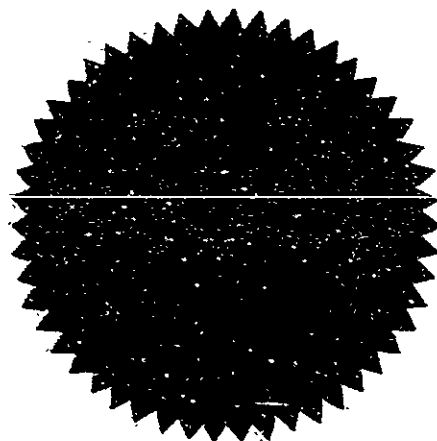



The undersigned, being of the age of eighteen years does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

1. The name of the corporation is S. & J. ThruWay, Incorporated
2. The period of duration of the corporation is perpetual.
3. The purposes for which the corporation is organized are:
 - a. To engage in the business of the wholesale and retail sale of ice cream products; and
 - b. To engage in any lawful act or activities for which corporations may be organized under Chapter 55, of the general statutes of North Carolina and to engage in those activities on earth or in space.
4. The corporation shall have the authority to issue 10,000 shares of One Dollar (\$1.00) par value.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is Five Thousand Dollars (\$5,000.00) in cash or property of equivalent value.
6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasury shares of the corporation.
7. The address of the initial registered office of the corporation in the State of North Carolina is 260 South Stratford Road, Winston-Salem, Forsyth County, North Carolina and the name of its initial registered agent at such address is John L. Hash.
8. The number of directors constituting the initial board of directors shall be two (2); and the names and addresses of the persons
