

## WARRANTY DEED

THIS INDENTURE WITNESSETH that K & P Properties, an Indiana general partnership, consisting of Thomas W. Kelley, Suzanne E. Horton (formerly known as Suzanne E. Posther), and Fort Wayne National Bank, as Trustee of a Trust Agreement entered into between James K. Posther, Settlor, and Fort Wayne National bank, as Trustee, dated November 9. 1962, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do bargain, sell and convey to KENNETH M. CHILTON and FRANCES J. CHILTON, husband and wife, the following described real estate in Forsyth County in the State of North Carolina, to wit:

FOR DESCRIPTION SEE EXHIBIT "A" ATTACHED HERETO AND INCORPORATED HEREWITH BY REFERENCE AS IF FULLY SET FORTH HEREIN.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereunto belonging to the said parties of the second part and their heirs and assigns forever.

And the said parties of the first part do covenant that they are seized of said premises in fee and have the right to convey the same in fee simple; that the same are free from encumbrances; and that they will warrant and defend the title to the same against all persons whatsoever, subject, however, to easements, restrictions, and limitations of record, as well as applicable zoning ordinances.

## EXHIBIT "A"

BEGINNING at a point in the northern boundary of 32nd Street, said point being marked by an iron stake at the base of a power pole located approximately 220 feet west of the intersection of 32nd Street and Indiana Avenue, and being at the intersection of the northern line of 32nd Street with the western line of a 15-foot alley; running thence with the northern line of 32nd Street North 89° 31' 47" West 788.79 feet to an iron at the southeastern corner of Lot 7F of Tax Block 3408 appearing on the Forsyth County Tax Maps; thence with the eastern line of Lot 7F North 15° 37' 09" East 235.34 feet to a point marked by an iron in the eastern line of Lot 7F, at a corner of Lot 7F with Woodlawn Cemetery; thence along the southern line of Woodlawn Cemetery South 89° 38' 46" East, crossing an iron at 1.32 feet, and continuing 721.90 feet for a total of 723.22 feet to a point marked by an iron at the northwestern corner of the aforementioned 15-foot alley; thence with western line of said alley South 00° 33' 04" East 228.67 feet to the point and place of BEGINNING, containing 3.95 acres and being known as Lot 9, Tax Block 3408, and being the same property described in a quitclaim deed from Ryder Truck Rental, Inc., successor-ininterest by merger to Fort Wayne Leasing Co., Inc. to K & P Properties, an Indiana partnership, recorded in Book 1294, Page 608, in the Office of the Register of Deeds of Forsyth County, North Carolina.

Notwithstanding the foregoing metes and bounds description, the property intended to be conveyed hereby shall include all property described in the aforementioned quitclaim deed.

The land described above by metes and bounds is shown on a plat of survey dated August 31, 1987, entitled "Boundary Survey for Kenneth M. Chilton and wife, Frances J., Winston Township, Forsyth County, N.C.," prepared by John G. Bane and Associates, P.A., Civil Engineers, and designated Job No. 8502.
