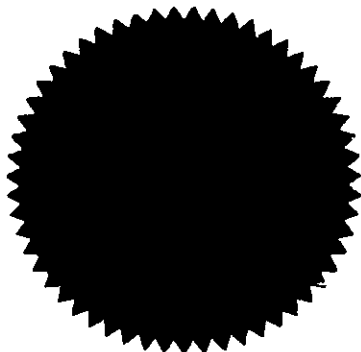

ARTICLES OF AMENDMENT  
OF

The undersigned corporation hereby executes these Articles of Amendment for the purpose of amending its charter:

1. The name of the corporation is: Bell's Printing Service, Inc.

2. The following amendment to the charter of the corporation was adopted by its shareholders on the 6<sup>th</sup> day of June, 1987, in the manner prescribed by law: DATE OF ADOPTION: JUNE 1987

RESOLVED, that Article I of the Charter of the corporation is hereby amended and henceforth shall read as follows: THAT THERE

The name of the corporation is G & V Bell, Inc. SECRETARY OF STATE

3. The number of shares of the corporation outstanding at the time of such adoption was 32,600; and the number of shares entitled to vote thereon was 32,600.

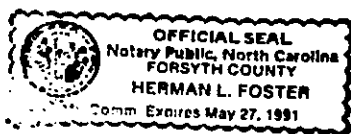
