

The undersigned natural person of the age of eighteen yearsture or more, does hereby establish a business corporation under the state of North Carolina as contained in Chapter of the General Statutes of North Carolina, entitled "Business Cotp Tarillum oration Act," and the several amendments thereto, and to that end does hereby set forth:

- 1. The name of the Corporation is G & S BUILDERS, INC.
- 2. The period of duration of the Corporation shall be perpetual.
- 3. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
- 4. The aggregate number of shares which the Corporation shall have authority to issue is 100,000 all of one class having a par value of \$1.00 per share.
- 5. The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is \$1.00 in cash or property of equivalent value.
- 6. The address of the initial registered office of the Corporation is 549 Arbor Hill Road, Apartment 64-A, Forsyth County, Kernersville, North Carolina, 27284, and the name of the initial registered agent at such address is Graham Sherrill Shumate.
- 7. The number of directors of the Corporation may be fixed by the Bylaws, but in no event shall the number be less than the minimum required by law.
