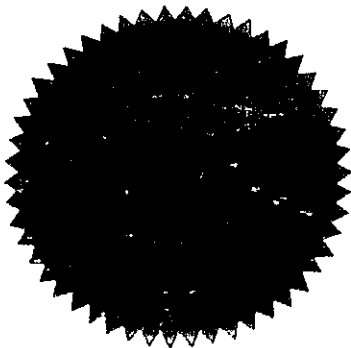

We, the undersigned natural persons of the age of eighteen years or more, do hereby associate ourselves into a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

1. The name of the Corporation is W & M Builders, Inc.

2. The period of duration of the corporation shall be perpetual.
(May be perpetual or for a limited period)

3. The purpose or purposes for which the corporation is organized are:

To engage in any lawful act or activity for which any corporation may be
organized under North Carolina General Statutes, Chapter 55-7.

4. The aggregate number of shares which the corporation shall have authority to issue is
10,000, divided into one classes. The designation of each class, number of shares

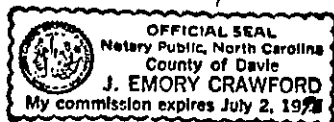
