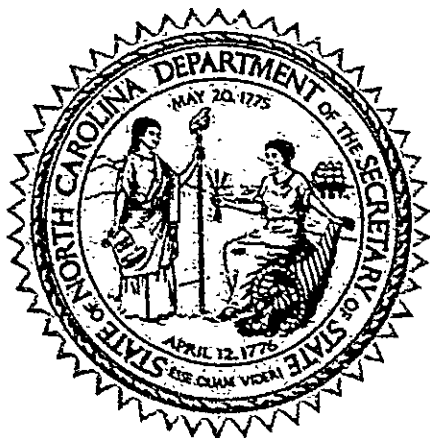

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
Q C ENGRAVING, INC.

The undersigned Corporation hereby executes these Articles of Amendment for the purpose of amending its Articles of Incorporation:

1. The name of the Corporation is:
Q C Engraving, Inc.

2. The following amendments to the Articles of Incorporation of the Corporation were adopted by its Shareholders on the 31 day of August, 1989, in the manner prescribed by law:

(A) Article 1. of the Articles of Incorporation is amended to read as follows: "The name of the Corporation is "Cooper-Quiett, Inc."

3. The stated capital shall not be changed by these Articles of Amendment and shall remain the same.

4. The number of shares of the Corporation outstanding at the time of such adoption was 5,000 and the number of shares entitled to vote thereon was 5,000.

5. The designation and number of outstanding shares of each class entitled to vote was as follows:

<u>Class</u>	<u>Number of Shares</u>
Common Stock, no par value per share	5,000

6. The number of shares voted for such amendment was 5,000 and the number of shares voted against such amendment was -0-.

7. The forgoing Amendment does not give rise to dissenter's rights under Section 101(b) of the General Statutes of North Carolina because the Amendment does not change the Corporation into a non-profit corporation or a cooperative organization nor does it prejudice or modify the rights of any holder of shares entitled to preference as to dividends or liquidation. Such Amendment herein effected only changes the name of the Corporation as hereinabove set forth.

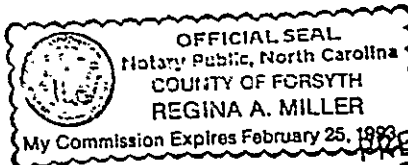
