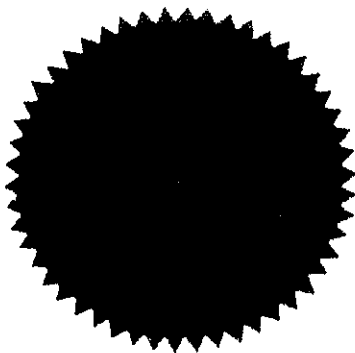

I.

The name of the corporation is W & W PROPERTIES, INC.

II.

The period of duration of the corporation is perpetual.

III.

The purpose for which the corporation is organized is
to engage in any lawful act or activity for which corporations
may be organized under Chapter 55 of the General Statutes of
North Carolina.

IV.

The corporation shall have authority to issue 100,000
shares with \$1.00 par value.

V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred Dollars (\$100.00) in cash or property of equivalent value.

VI.

VII.

No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for breach of duty by such director as a director; provided, however, that this Article VIII shall not eliminate the liability of a director (unless otherwise permitted by applicable law), (i) for acts or omissions not in good faith that the director, at the time of the breach, knew or believed conflicted with the best interests of the corporation; (ii) under North Carolina General Statutes § 55-32, as it may be amended from time to time; (iii) for any transaction from which the director derived an improper personal benefit; and (iv) for acts or omissions occurring prior to the adoption of this Article. No amendment to or repeal of this Article VIII shall apply to or have any effect on the liability or alleged liability of any director of the corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal.
