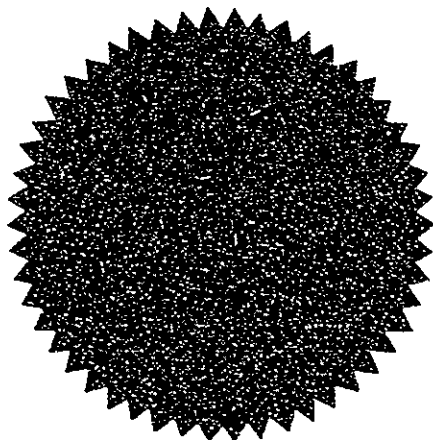

ARTICLES OF INCORPORATION

OF

F & S ASSOCIATES OF WINSTON-SALEM, INC. RUFUS L EDMISTEN
SECRETARY OF STATE
NORTH CAROLINA

I, the undersigned natural person of the age of eighteen (18) years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

I.

The name of the corporation is F & S ASSOCIATES OF WINSTON-SALEM, INC.

II.

The corporation shall have authority to issue 100,000 shares of common stock.

III.

The address of the initial registered office of the corporation in the State of North Carolina is: 380 Knollwood Street, Suite 700, Winston-Salem, Forsyth County, North Carolina 27103. The name of its initial registered agent at such address is Donald M. VonCannon.

IV.

The name and address of the incorporator is: Jack B. Styles, 211 Six Forks Road, Suite 204, Raleigh, North Carolina 27609.

V.

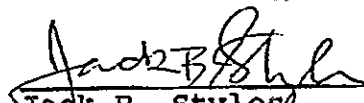
No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for breach

of duty by such director as a director; provided, however, that this Article V shall not eliminate the liability of a director (unless otherwise permitted by applicable law), (i) for acts or omissions not in good faith that the director, at the time of the breach, knew or believed conflicted with the best interests of the corporation; (ii) under North Carolina General Statutes §55-8-33, as it may be amended from time to time; (iii) for any transaction from which the director derived an improper personal benefit; and (iv) for acts or omissions occurring prior to the adoption of this Article. No amendment to or repeal of this Article V shall apply to or have any effect on the liability or alleged liability of any director of the corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal.

VI.

These Articles of Incorporation shall be effective upon filing.
