## ASSIGNMENT OF LEASE

THIS ASSIGNMENT, made and entered into by and between LOWE'S FOOD STORES, INC., a North Carolina corporation, hereinafter referred to as "Assignor" and G & B OIL COMPANY; INC., North Carolina corporation, hereinafter referred to as "Assignee";

## WITNESSETH:

In consideration of Ten Dollars (\$10) and other good and valuable consideration, Assignor does hereby sell, assign, transfer and convey unto Assignee all of its rights, title and interest in and to that certain Sublease Agreement (Run-In #715) dated November 18, 1981, between J. C. Faw, as Lessor, and Lowe's Food Stores, Inc., as Lessee, a copy of which is attached hereto as Exhibit A. A memorandum of said Sublease is recorded at Book 1355, Page 1052 of the Forsyth County Registry. The commencement date of the sublease was January Said sublease has a term of twenty (20) years together with three (3) successive five (5) year options to renew. Said sublease covers a portion of the property leased by Dillon & Hastings Real Estate, Inc., as Landlord to J. C. Faw, as Tenant, by lease dated April 15, 1977, a copy of which is attached hereto as Exhibit B. A MCMo of said Lease 15 recorded in Book 1355-1049. The Assignee, by acceptance of this Assignment of Lease, does hereby assume and agree to comply with the terms and
