EXHIBIT A

BEGINNING at an iron stake in an old lake site the northwest corner of a 3.05 acre tract, which iron stake being North 20° 30' East and 339.65 feet northeastwardly of an iron stake in the north line of the Dennis Norman property, and running thence North 20° 30' East 200.0 feet to an iron stake at a lake; thence the three following courses and distances with said lake viz: North 69° 02' East 122.30 feet to an iron stake; South 78° 46' East 65.0 feet to an iron stake; and South 47° 52' East 100.0 feet to an iron stake, the northwest corner of a 2.10 acre tract; thence with the west line of said tract, South 1.0° 15' East 309.22 feet to an iron stake in the north line of a 3.05 acre tract; thence with said tract, North 64° 25' West 365.10 feet to the point of BEGINNING, containing 1.94 acres, more or less. This description was prepared by June Linebach, Registered Surveyor, on May 5, 1971.

Together with the above described property, the grantors herein grant to the grantees all of their right, title and interest in and to a continuing, permanent non-exclusive easement for ingress and egress along a proposed 20 foot roadway which easement is recorded in Book 1118, page 535 of the Forsyth County, North Carolina Registry and along an existing 20 foot roadway which easement is described in Deed recorded in Deed Book 1016, page 920 of the Forsyth County, North Carolina Registry, and in Deed recorded in Deed Book 1016, page 918 of the Forsyth County, North Carolina Registry.

The grantors further assign to the grantees all rights granted to them under that certain Lease Agreement between W. F. Maready and wife, Sallie Millis Maready; R. M. Stockton, Jr. and wife, Frances B. Stockton; R. G. Stockton and wife, Edmonia R. Stockton and grantors dated May 6, 1971.
