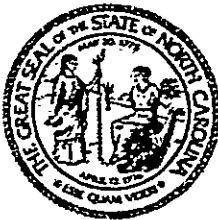

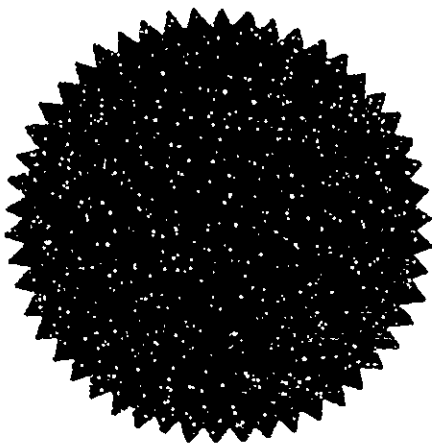

ARTICLES OF ORGANIZATION

The undersigned hereby submit these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of North Carolina.

1. The name of the limited liability company is N & N PUBLISHING, LLC.
2. The latest date on which the limited liability company is to dissolve is December 31, 2025.
3. The name and address of each Organizer executing these Articles of Organization are:



4. The street address of the initial registered office of the limited liability company in the State of North Carolina, Forsyth County, is 5004 Meadow Hill Court, Winston-Salem, North Carolina; and the name of its initial registered agent at such address is Brad L. Nickum.

5. Except as provided in Section 57C-3-20(a) of the North Carolina General Statutes, the members shall not be managers by virtue of their status as members.

6. No person who is serving or who has served as a manager of the limited liability company shall be personally liable to the limited liability company or any of its members for monetary damages for breach of duty as a manager, except for liability with respect to (1) acts or omissions that the manager at the time of such breach knew were clearly in conflict with the best interests of the limited liability company, (2) any transaction from which the manager derived an improper personal benefit; (3) acts of omission occurring prior to the effective date of this article, or (4) acts or omissions with respect to which the North Carolina Limited Liability Company act does not permit the limitation of liability. As used herein, the term "improper personal benefit" means a reasonable incidental benefit for or on account of his services as a manager, employee, independent contractor, attorney or consultant of the limited liability company. No amendment or repeal of this article, nor the adoption of any provision of these Articles, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
