ASSIGNMENT OF LEASE
(Store #2112)

THIS ASSIGNMENT OF LEASE made this 25 day of June, 1998, by and between WINN-DIXIE CHARLOTTE, INC., a Florida corporation ("Assignor") and W-D TRANSFER, INC., a Florida corporation ("Assignee").

WITNESSETH:

In consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable considerations in hand paid by the Assignee to the Assignor, receipt whereof is hereby acknowledged, and of the acceptance hereof by the Assignee, the Assignor does hereby assign, set over and transfer absolutely unto the Assignee, its successors and assigns, the following lease, properties, rights and obligations (the "Lease"):

That certain Lease dated April 20, 1987, between Marquis Properties-Walkertown, Ltd., a Georgia limited partnership, as Landlord, and Winn-Dixie Charlotte, Inc., a Florida corporation, as Tenant, as evidenced by and/or modified by the following instruments: Short Form Lease dated April 20, 1987, recorded in Official Records Book 1608, Page 1334; Amendment to Short Form Lease dated March 20, 1998, recorded in Official Records Book 1993, Page 3178, of the Public Records of Forsyth County, North Carolina; as modified by Letter Agreement dated May 19, 1987; Supplemental Lease Agreement dated January 26, 1988; and Amendment to Lease dated March 20, 1998.

TO HAVE AND TO HOLD the same unto the Assignee, its successors and assigns, for and during the remainder of the term thereof, subject to the payment of the rents and the performance of the covenants, conditions and provisions therein contained.

AND said Assignor covenants that said Lease is valid and subsisting, that Assignor is the lawful owner of all the options, rights, title, interest and estate of every kind of the Tenant under the Lease and in and to the leased premises and all building, structures, leaseholds and other improvements thereon, that all such options, right, title, interest in state are free and clear of all liens, encumbrances and assignments, but subject, however, to, the terms, conditions, limitations and restrictions contained in the Lease, and that Assignor has full power and lawful authority to convey the same.

ASSIGNEE, by accepting this Assignment, assumes and agrees to pay the rent, perform all covenants, conditions and provisions in the Lease to be paid, performed and observed by Tenant thereunder.

THIS ASSIGNMENT shall bind and enure to the benefit of the successors and assigns of the Assignor and Assignee, respectively.
