APPOINTMENT OF SUBSTITUTE TRUSTEE

TAKE NOTICE THAT WHEREAS on or about May 31, 1991, MARY H. HEMPHILL executed a promissory note (the "Note") in the amount of \$48,900.00 to FIRST UNION NATIONAL BANK OF NORTH CAROLINA, and on the same date, Mary H. Hemphill (Legally Seperated) executed a Deed of Trust conveying the property therein to THOMAS E.
