The release of the land hereinabove shall not result in the discharge by the Estate of Ann P. Ryan of any person or party to the note secured by the aforementioned Deed of Trust. The Estate of Ann P. Ryan does hereby reserve against all parties to the note all rights of a holder under the Uniform Commercial Code as adopted (and from time to time amended) in North Carolina.
