

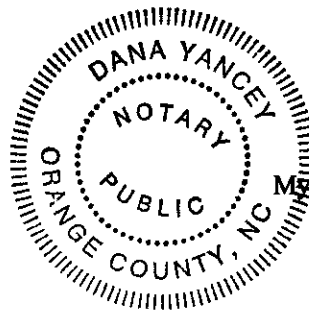

## Exhibit A

BEGINNING at an iron stake at the southern right of way of Jarvis Street, said iron stake being the northeast corner of Lot 22 as shown on the Plat of Crafton Heights as recorded in Plat Book 2, Page 36(4), Forsyth County Registry; thence with the eastern line of said Lot 22, South 29° 42' East 54.3 feet to an iron stake, said iron stake being the northeast corner of Lot 21 of aforementioned Crafton Heights; thence with the northern line of Lot 21, South 59° 48' West 61.77 feet to an iron stake; thence on a new line North 34° 43' West 54.37 feet to an iron stake in the northern line of aforementioned Lot 22; thence with the northern line of Lot 22, North 59° 50' East 62.77 feet to the place of beginning and containing 3,218 square feet, more or less.
