THIS DEED, made this the 14<sup>th</sup> day of November, 2019, by and between **Jeffrey Dale McCroskey, Craig Alan McCroskey, and Donna Jo McCroskey, Trustees of the V. Donald McCroskey Trust UA dated July 26, 2002;** and **Craig Alan McCroskey, as Executor of the Estate of V. Donald McCroskey** (mailing address: 1845 Philpott Drive, Bassett, VA 24055), hereinafter referred to as **Grantor**; and, **Jon Taylor Golenbiewski and wife, Elizabeth Woodland Mumaw** (mailing address: 3856 Cedarfield Place Court, Winston-Salem, NC 27106), hereinafter referred to as **Grantee**.

### WITNESSETH:

WHEREAS, V. Donald McCroskey (hereinafter referred to as the "Decedent") died on April 6, 2019 seized of the real property described below in fee simple, and the Last Will and Testament of the Decedent has been duly probated and recorded in the Office of the Clerk of Superior Court of Forsyth County, North Carolina, bearing Estate File Number 19 E 1616; and,

WHEREAS, Item V of the Last Will and Testament of the Decedent (hereinafter referred to as the "Will") appointed the Decedent's three children as Co-Executors of the Estate, two of whom renounced the right to act as such, and with Craig Alan McCroskey having so qualified; and,

WHEREAS, Item III of the Will bequeathed and conveyed the residuary estate of the Decedent, including real property, to V. Donald McCroskey Trust Under Agreement dated July 26, 2002, a certification of such trust is attached hereto as Exhibit A; and,

WHEREAS, notice to creditors of the estate was published as required by NCGS 28A-14-1.

NOW, THEREFORE, the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Forsyth County, North Carolina and more particularly described as follows:

**Tract 1:**

BEGINNING at an existing iron pipe, said iron pipe being the Northeast corner of Lot 4, Cedarfield Place, Plat Book 36, Page 25, Forsyth County Registry; running thence on a new line South 85° 07' 42" East 100.32 feet to a new iron pipe; running thence on a new line South 00° 17' 30" East 145.64 feet to a new pipe; running thence North 81° 59' 13" West 101.05 feet to an existing iron pipe the, Southeast corner of said Lot 4; running thence with the East line of said Lot 4 North 00° 15' 38" 140.07 feet to an iron pipe, the point and place of BEGINNING, and being a Western portion of Tax Lot 68B, Tax Block 3471, Forsyth County Tax Maps as presently constituted.

THIS CONVEYANCE IS MADE SUBJECT to the following restriction:

A 25 -foot strip along the Easternmost line of the above-conveyed property shall remain in its natural state as a buffer zone for a period of 35 years (from the date of recording of the deed recorded in Book 1917, Page 1169, Forsyth County Registry).

**Tract 2:**

BEING all of Lot No. 4 of "Cedarfield Place" - Section One, a plat of which is duly recorded in Plat Book 36, Page 25, Forsyth County Registry. Reference to said plat is hereby made for a more complete and accurate description. For reference see Forsyth County Tax Lot 68, Block 3471.


TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantee in fee simple.



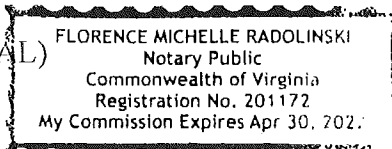

## **Certification of Trust for The V. Donald McCroskey Trust UA dtd 7/26/2002**

Under North Carolina General Statutes § 36C-10-1013, this Certification of Trust is signed by the currently acting Trustees of The V. Donald McCroskey Trust UA dtd 7/26/2002, who declare as follows:

1. The V. Donald McCroskey Trust (the "Trust") was established under a revocable trust agreement between V. Donald McCroskey as Grantor and V. Donald McCroskey as Trustee. V. Donald McCroskey died on April 6, 2019. The Trust is now irrevocable.
2. The Trustees of the Trust are Jeffrey Dale McCroskey, Craig Alan McCroskey and Donna Jo McCroskey.
3. The tax identification number of the trust will be provided upon request to the Trustees.
4. Title to assets held in the trust shall be titled as:

Jeffrey Dale McCroskey, Craig Alan McCroskey, and  
Donna Jo McCroskey, Trustees of the V. Donald  
McCroskey Trust UA dtd 7/26/2002.
5. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust agreement.

- 6. The Trust agreement provides that the Trustees may act by majority action. The Trust agreement provides that the Trustees have all of the powers set forth in N.C. Gen. Stat. § 32-27. Excerpts from the trust document that establish the Trust, designate the Trustees and set forth the powers of the Trustees will be provided upon request. The powers of the Trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.
- 7. The trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

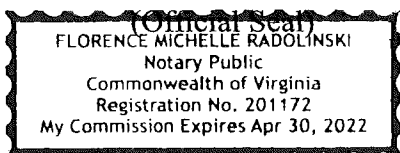
